- Prepares/Approves the deviations and exceptions from the change and quality plan for the projects they coordinate; Prepares and implements specific procedures for technical and production systems, computerized equipment systems and ensures the personnel who use them are properly trained regarding the provisions of those procedures;
- Participate in GMP, workplace-specific, HSE and P&O trainings; Participate in the Evolve performance management process based on objectives, frequent check-ins, recognition and rewards; Keeps the confidentiality of the data and information to which it has access to and which are classified as restricted or confidential;
