You will develop and improve and facilitate contractor safety programs for the Cambridge site. You will develop the framework for the management of potential risks to human health and/or the environment resulting from activities involving facility maintenance operations.

About the Role

Key responsibilities:

Facility Health & Safety Programs:

- **Facilitate safety compliance programs such as confined space entry, lockout/tag out, hot work and fall protection, electrical safety and job hazard analysis programs that are appropriate in consideration of the site's complexity, population, regulatory burden/environment, criticality and location.**
- **In collaboration with project managers, leads commissioning safety programs associated with design and construction management activities at the site. This may involve daily management of contract resources.**
- **Develops and leads implementation of safety critical preventative maintenance and inspection programs.**
- **Builds, implements, and provides long term management to facility self-inspection programs.**

Project / Contractor Safety:

- **Develops and maintains site contractor safety program, including pre-qualification and training processes.**
- **Conducts HSE management for capital project reviews, including new facility assessments and decommissioning activities.**
- **Participation hazardous operations safety assessments for facility and scientific operations.**

Fire/Life Safety

- **Provides technical expertise and oversight for facility fire protection systems and code compliance programs, including management of consultants.**
- **Leads Collaborate with FM Global and provides management of recommendation & implementation action plans.**

Role Requirements:

Experience :-

- **1-3 years of relevant HSE program experience, preferably with knowledge and experience with facilities-based safety programs and contractor safety programs**
- **A solid understanding of pharma industry and the nuances of pharma HSE issues is a plus.**
- **Highly motivated self-starter with a proven track record to assume accountability & responsibility, take ownership for their work, and intelligently challenge the status quo.**
- **Competency in analytical and problem-solving skills.**
- **Strong leadership, influencing and communication skills.**
