- Work with business owners to establish acceptable deviations to the specifications in order to justify alternative materials and products.
- Introduction of the selected suppliers to the site: Coordinate change request approval and SAP database update
- Data Analysis and Reporting: Analyze procurement data and prepare reports related to disruptive sourcing, including cost savings, supplier performance, and market trends. Present findings to management and customers as required.
