- Serve as the liaison between business stakeholders, IT, and external vendors to ensure that business requirements are effectively captured, understood, and executed.
- Collaborate closely with platform architects, developers, and testers to ensure that solutions are designed and implemented to meet business requirements.
- Manage relationships with the business analyst vendor team, ensuring that vendor-delivered business analysis aligns with internal standards and objectives.
- Collaborate with the testing team to ensure that test plans, test cases, and validation processes align with the business requirements.
- Ensure compliance with GxP, regulatory requirements, and quality standards, particularly for validation testing.

- Ensure that all business requirements, processes, and related documentation are accurately captured and maintained.
- Provide regular updates and reports to senior leadership on the status of business analysis efforts, platform enhancements, and ongoing initiatives.
