(In-depth knowledge of cross-functional business operating models.) Understand tangential processes and systems that interact/interface with S2P. Drives S2P systems implementations in support of end to end (E2E) strategy.

Fosters a balance between customer centric service delivery and core process compliance. (Has the ability to coach themselves and others through change).
