- Support user acceptance testing to enable local organization endorsement and support for positive "Go" decision.
- Facilitate effective collaboration between Functional and Business experts (e.g. country, NOCC, HUB, etc.) to achieve sustainable process solutions.
- Define clear roles and responsibilities for each stakeholder group and communicate them effectively.
- Monitor the progress and quality of the Final Adopt activities and provide timely feedback and guidance.
- Ensure that the risks and issues are properly identified, assessed, mitigated and escalated as needed.
