This role is required to be in our East Hanover, NJ office 3x/week.

- Contribute to the research and collection of threat information from multiple sources, based on agreed intelligence requirements, and using this to create timely, clear, accurate and actionable security intelligence, threat assessments, management briefings, security alerts, country risk assessments, source reports, multi-media presentations, workshops, and training
- Monitoring of geopolitical updates and providing succinct summaries in support of intelligence team and business continuity teams
- Provide project support to Meetings, Congresses and Events Security supporting procurement processes and threat assessment
- Provide support to the global background screening process
- Provide administrative and project support to the GS-Americas and the Legal IP Team (10% of role)
