- Involve in HSE and Quality audits in his responsibility area, ensure all audit actions are completed within deadlines Shop Floor Resource planning; ensure production is in line with budget targets and defined resources (people, equipment, material, service, overtime, absenteeism etc.
- Responsible for technical batch release for manufacturing; SOP reviews and revisions

- Manage external shop floor employee workload (room, tool, container cleaning and supply)
