- This requires strong collaboration within GDPD organisation (Global Device & Packaging Development, Device & Packaging Technology and Human Factors Engineering) and with partners like Technical Operations, Clinical Development, Drug Development.
- You develop and support your team for best possible performance short- and long-term, you support your team in challenging projects and for strategic presentations as needed.
- You drive further development of high-quality efficient and effective approaches and processes for risk management and control strategy, inline with Novartis and external requirements, at the forefront of / shaping future approaches.
- You act proactively in building the culture to enable high employee engagement; seek for diversity and a high performing, supportive team • You contribute to and review regulatory documents, supporting product

registrations and presenting at inspections.
