- Ensure standardized design and development processes to enable efficient delivery jointly with supplier partner. Conduct service handover and lead the go-live authorization discussions with the other work streams.
- Ensure that all release and deployment packages can be tracked, tested, verified and backed out (if required). Ensure that release delivers the expected outcomes and value for the customers.
- Take accountability to ensure alignment with Security and Compliance policies and procedures within Solution Delivery scope. Responsible for monitoring the performance of automated processes and measuring the impact of automation initiatives by establishing key performance indicators (KPIs) to track the efficiency, effectiveness, and ROI of automation projects.

- Proven track record and expertise in designing, deploying and operating SAP Business process automations, preferably with knowledge in Automation technologies like SAP Build Process Automation, IRPA etc..

- Extended experience with Agile tools and techniques.
