- **Issue Escalation:** Serve as the escalation point for raw material testing issues across various external and internal Novartis testing sites.
- **Quality Oversight:** Provide quality oversight for raw material testing and relevant processes.
- **Single Point of Contact (SPOC):** Act as the Quality Operations SPOC for control procedure updates across testing labs and Pharmacopoeia updates.
- **Project Implementation:** Act as the Quality SPOC for implementation of the reduced testing in course of the material certification process
- **Audit Expertise:** Act as a subject matter expert (SME) during health authority and customer audits.
